

## **Friends and Family Eligibility Requirements**

### Initial Application User Must:

- Be an exempt State Farm employee (non-timecard) in working at Corporate locations or Phoenix, Dallas, or Atlanta hubs.
- Be currently responsible for, or assisting with, the care of a senior family member on a regular basis
- Have at least one other person who is willing to join your care circle and meeting these requirements (see below)

### Be willing to download and interact with the Life Sync™ by State Farm® application

- Be willing to provide feedback via online surveys and/or phone interviews
- Be willing to allow user engagement data and usage data to be collected for analysis to validate core assumptions of value and desirability
- Have access to an Android or iOS smart-phone (see technical specifications) with internet access outside of working hours
- Have a personal email address
- Agree to Terms of Use and Notice of Privacy (provided with onboarding in application and device)
- Not be operating under court ordered guardianship for the senior
- Understand that the value of the device will be reportable as income for tax purposes
- Provide State Farm alias for tax reporting purposes

### Subsequent Application Users must:

- Currently reside in the US
- If a State Farm employee, must be exempt (non-timecard)
- Be willing to download and interact with the Life Sync™ by State Farm® application
- Be willing to provide feedback via online surveys and/or phone interviews
- Be willing to allow user engagement data and usage data to be collected for analysis to validate core assumptions of value and desirability
- Have access to an Android or iOS smart-phone (see technical specifications) with internet access outside of working hours
- Have a personal email address
- Agree to Terms of Use and Notice of Privacy (provided with onboarding in application and on device)
- Not be operating under court ordered guardianship for the senior

### Senior must:

- Have an Amazon account and know their username and password (does not have to be a Prime account)
- Must have access to a web browser OR an Android or iOS smart-phone that meet the technical specifications.
- Reside in the US throughout the year
- Have a personal email address
- Have mental capacity to consent to participate

- Be willing to interact with the Amazon Life Sync™ skill on a voice and touch activated Amazon Echo Show™ device on a daily basis
- Have Wi-Fi access in their home or living quarters. The Amazon Echo Show™ device will not work with a hard-wired connection, mobile tethering or with internet speeds under 500kbps.
- Be willing to provide feedback via online surveys and/or phone interviews
- Be willing to allow user engagement data and usage data to be collected for analysis to validate core assumptions of value and desirability
- Agree to Terms of Use and Notice of Privacy (provided with onboarding on device)
