

## **Life Sync™ Terms of Service**

Last Updated November 11, 2019

### **I. Introduction to Life Sync**

Life Sync is a digital solution provided to you by Go Right, LLC (“Go Right”), a wholly owned subsidiary of State Farm Mutual Automobile Insurance Company (“SFMAIC”), as part of your participation in the Life Sync pilot program (“Pilot”).

Life Sync uses the Life Sync mobile application (“Life Sync Application”) and Life Sync Alexa Skill (“Life Sync Skill”) (together, the “Life Sync Services”) to help you stay connected, interact, and share information with an aging loved one (Senior), and the other important people in the Senior’s life (“Care Circle”).

As part of your participation in the Pilot, Go Right has provided the Senior with an Amazon Echo Show device (“Amazon Echo”), and has provided you with the Life Sync Services to be used on your mobile device. In order to use the Life Sync Services, the Senior will need to set up the Amazon Echo and download the Life Sync Skill using an Amazon account.

After the Senior has set up the Amazon Echo and downloaded the Life Sync Skill, you will need to download the Life Sync Application and create an account. Once you download the Life Sync Application and create your account, you will be part of the Senior’s Care Circle, and will be able to use the Life Sync Services.

### **II. Life Sync Terms of Service**

These Terms of Service (“Terms”) govern your access to and use of the Life Sync Services, and are a binding agreement between you and Go Right. You should carefully read these Terms to make sure you understand them. You acknowledge and agree that, by accessing or using the Life Sync Services, you are indicating that you have read, understand, and agree to be bound by these Terms. If you do not agree to these Terms, you do not have any right to access or use the Life Sync Services.

Life Sync Services use the Amazon Echo and Life Sync Skill; by accepting and agreeing to these Terms, you acknowledge and agree that you have reviewed, understood, and agreed to the Amazon Device Terms of Use (“Amazon Device Terms”) that can be found at:

### **III. Life Sync Pilot**

The Life Sync Services are provided to you in connection with your participation in the Pilot. During the Pilot, your use of the Life Sync Services will be free of charge. At the conclusion of the Pilot, you will have the option to either sign up for a subscription to the Life Sync Services, or discontinue using the Life Sync Services.

### **IV. Capacity and Consent**

You may not use the Life Sync Services unless the Senior has the capacity to read, understand, and agree to the terms of service provided for his or her review upon activation of the Skill on the Amazon Echo (“Senior Terms”). By accepting these Terms and using the Life Sync Services, you are attesting that the Senior has read, understood, and agreed to the Senior Terms, and that the Senior is not the ward of a court-ordered guardianship, and has not been otherwise declared to lack mental capacity to enter into a contract by a court or physician.

You agree that by using the Life Sync Services, the Senior has authorized you to view, access, and otherwise use the information shared through the Life Sync Services, as more particularly described in these Terms, below. Under no circumstances shall consent to these Terms operate as a grant of a statutory power of attorney.

The Senior may at any time revoke his or her consent to your access to and use of his or her information via the Life Sync Services by deleting you from the Care Circle.

## **V. Account Registration**

In order to access and use the Life Sync Services, you must register to create an account. You agree to provide accurate, current and complete information during the registration process and to update such information to keep it accurate, current and complete. Go Right reserves the right to suspend or terminate your account if any information provided during the registration process or thereafter proves to be inaccurate, not current, or incomplete. As part of the registration process, you will be asked to create a password. You are responsible for remembering and safeguarding your password. You agree that you will not disclose your password to any third party and that you will take sole responsibility for any activities or actions taken through your account, whether or not you have authorized such activities or actions. If you become aware of any unauthorized use of your account, you agree to immediately notify Go Right.

## **VI. Eligibility**

The Life Sync Services are intended solely for persons who reside in the United States (excluding residents of California). You may not use the Life Sync Services if you are not a resident of the United States, or if you are a resident of California.

You may not use the Life Sync Services unless you are age 18 or older. Any access to or use of the Life Sync Services by anyone under the age of 18 is expressly prohibited. By accessing or using the Life Sync Services, you represent that you are at least 18 years old.

## **VII. Care Circle Connection to the Senior**

As part of your use of the Life Sync Services, you and other members of the Care Circle will connect to and receive information from the Senior using the Life Sync Services. If you want to add an additional member to the Care Circle, you may do so using the Life Sync Application; however, any added member will not have access to the Care Circle until the Senior approves his or her access. The Senior may consent to add an unlimited number of individuals to the

Care Circle, and may delete any member of the Care Circle at any time. The Care Circle should be limited to those people with whom the Senior wants to share his or her information. If you want to be removed from the Care Circle, you must request that the Senior delete you from the Care Circle.

Any information you put into the Life Sync Application or share with the Senior through the Life Sync Services will be stored and available to each Care Circle member in Life Sync Application. Go Right does not monitor the information you share with the Senior and other members of the Care Circle. You are solely responsible for any and all information you share with the Senior and other members of the Care Circle. You should not share any information unless you are comfortable with and consent to the Senior and all members of the Care Circle receiving and having access to that information.

You agree that you will not allow any person not approved by the Senior to access, view, or otherwise obtain the Senior's information.

Go Right will not be liable for any information you receive from or share with the Senior and Care Circle using the Life Sync Services, or any harm or injury resulting from the receiving or sharing the information.

## **VIII. Life Sync Features**

- **Check-In**

The Life Sync Services include a "Check-In" feature, which enables the Senior to provide you and other members of the Care Circle with periodic updates about his or her day. Check-In allows the Senior to give a verbal update to the Amazon Echo, which the Amazon Echo then converts to text. Once the Amazon Echo converts the Senior's verbal update to text, the Senior will have the option to share his or her Check-In update with the Care Circle. Once the Senior has shared an update, you and all members of the Care Circle will be able to see it. Go Right shall not be responsible or liable for any incidental, special, exemplary, or consequential damages arising from use of the Check-In feature, or from the use of any information shared using the Check-In feature.

The Check-In feature also includes a "passive check-in" which will notify the Care Circle each time the Senior opens and/or interacts with the Life Sync Skill.

- **Calendar**

The Life Sync Services include a "Calendar" feature, which allows you to add and delete events, appointments, and other activities to the Calendar. Any other member of the Care Circle can add an event to the Calendar, or delete any event from the Calendar. The Senior can view all events added to the Calendar, but cannot add or delete events.

Calendar includes a free form text field "Notes" section. You should never enter sensitive personal information, including but not limited to financial or medical information, in the Notes section of Calendar. If you find that a member of the Care Circle has entered

sensitive personal information into Notes, you should notify the Senior and delete that information immediately.

- **Memories**

The Life Sync Services include a “Memories” feature, which allows you to share photographs with the Senior and other Care Circle members. Photographs shared using the Life Sync Services may be viewed by you, the Senior, and any other member of the Care Circle. Go Right does not view or monitor the content and is not responsible for photographs shared using the Life Sync Services. You may not share photographs using the Life Sync Services unless you have rights or permission to share them. By sharing photographs using the Life Sync Services, you are attesting that you have the right or permission to do so, including ownership and copyright rights. You agree that Go Right will not be liable for any injury or damages arising from photographs shared using the Life Sync Services, including but not limited to copyright infringement.

- **Lists**

The Life Sync Services include a “Lists” feature, which allows the Senior and Care Circle to create and share the following types of lists: To-Do, Grocery, and Wellness. Any member of the Care Circle can edit the lists. Seniors may view and add items to lists created and shared through the Life Sync Services, and may also check any list item as “complete.” Any list created using the Life Sync Services will be shared with the Senior and all members of the Care Circle.

## **IX. Use of the Life Sync Skill**

Your use of the Life Sync Services is enabled by the Life Sync Skill available to the Senior on the Amazon Echo. Any and all interactions you have with the Life Sync Skill by using the Life Sync Application are through Amazon. These interactions may be recorded by Amazon and used in accordance with the Amazon Device Terms.

By using the Life Sync Application to interact with the Life Sync Skill, you are authorizing Go Right to collect, use, and store information related to your use of the Life Sync Application and its interaction with the Life Sync Skill. Information collected by Go Right is subject to the terms set forth in the Privacy section, below.

You understand that your use of the Life Sync Application to connect with the Life Sync Skill is voluntary and that using the Life Sync Application to connect with the Life Sync Skill, you are representing that you have authority and capacity to use the Life Sync Application to connect with the Life Sync Skill in accordance with these Terms. You are solely responsible for using the Life Sync Application to interact and communicate with the Life Sync Skill. You may discontinue using the Life Sync Application to connect to the Life Sync Skill at any time, and acknowledge that if you choose to do so, your ability to use the Life Sync Services and share information with and receive information from the Senior may be limited or unavailable.

You agree and acknowledge that:

- Go Right is not responsible for any errors caused by inaccurate information captured by the Amazon Echo during an interaction between the Life Sync Skill and Life Sync Application;
- Information you share with the Life Sync Skill using the Life Sync Application will be transferred through Amazon and any request you make using the Life Sync Skill will be shared with Amazon;
- Go Right makes no warranties regarding the use or operation of the Life Sync Skill in connection with the Life Sync Application, including, but not limited to, any warranty interactions between the Life Sync Application and the Life Sync Skill will be error free or uninterrupted

Go Right shall not be liable to you for any direct, indirect, consequential, incidental, or special damages (including, without limitation, loss or destruction of data) arising out of using the Life Sync Application to connect with the Skill, regardless of the theory of liability.

## **X. Privacy**

The privacy terms described in this section apply to your access to and use of the Life Sync Services, and by choosing to use them, you consent to the collection, transfer, processing, storage, disclosure, and other use of your information described in this section.

When you use the Life Sync Skill to share information with the Senior and other members of the Care Circle, Go Right will collect and store any information that you share via the Life Sync Services, as well as any information that you or other members of the Care Circle provide, store, manage, or otherwise share using the Life Sync Application, which may include but is not limited to the following:

- Email address
- First and Last Name
- Username
- Password
- Gender
- Date of birth
- Care Circle members
- Medical information [Note: you should never use Life Sync to share or store medical information]
- Financial information [Note: you should never use Life Sync to share or store financial information]
- Personal contacts
- Calendar events
- List items

- Photographs and files
- Notes

In addition to the information described above, Go Right may collect the following information any time the Life Sync Services are used:

- **Usage data**—when you use the Life Sync Application, or when the Senior connects with the Life Sync Application using the Life Sync Skill, Go Right automatically records any and all information that the Amazon Echo Show collects and transmits to the Life Sync Application (“Usage Data”). This Usage Data may include information such as your device model and version, device identifier, operating system, time zone, name of your mobile operator or internet service provider, application performance measurements, and error conditions. It may also include a record of when specific features of the Life Sync Skill or Life Sync Application are used. Go Right uses this information to monitor and analyze use of the Life Sync Services and their technical administration, to increase their functionality and user-friendliness, and to better tailor them to the needs of you, the Senior, and other members of the Care Circle. For example, we use this information to measure the popularity of different features and to more effectively resolve any technical issues that you, the Senior, or other members of the Care Circle encounter when using the Life Sync Services.

The Senior and each member of the Care Circle will have access to any and all information shared by you through the Life Sync Services. Go Right cannot control how the Senior or any member of the Care Circle may use or disclose any information you share using the Life Sync Services. You expressly release Go Right from any responsibility and liability resulting from allowing the Senior and other members of the Care Circle to access your information.

If you would like to delete any information associated with you, and your use of the Life Sync Services, please contact Go Right at 1-833-255-0228. We will use commercially reasonable efforts to honor your request. We will retain an archived copy of your information as set forth below.

Go Right will retain the information you provide via the Life Sync Services for as long as you are using the Life Sync Services. Go Right will also retain and use the information you provide via the Life Sync Services, as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements. If you discontinue use of the Life Sync Services, information associated with the same is moved out of Go Right’s active databases, but will still be retained in Go Right’s systems pursuant to its data backup and retention policies.

If you feel your information may have been compromised, please report it immediately by contacting Go Right at 1-833-255-0228.

Go Right does not currently sell your information. Nevada law requires that Nevada residents have the ability to opt out of the future sale of your information regardless of whether an entity actually sells information; if you do not want Go Right to sell your information in the future, you may opt out of the sale of your information by contacting Go Right at 1-833-255-0228, or by sending an opt-out email request to Go Right at [LifeSync@statefarm.com](mailto:LifeSync@statefarm.com).

Go Right does not share your information with SFMAIC, except as required under the services agreement between SFMAIC and Go Right. Go Right may share your information with third parties in conjunction with offering you the Services.

All information you, the Senior, or any other member of the Care Circle provides, stores, manages, and shares using the Life Sync Services will be stored by Amazon Web Services on a virtual private cloud. Go Right retains your information for legal, auditing, regulatory, and business purposes

Go Right will use any information you share through the Life Sync Services, or that is otherwise maintained to provide the Life Sync Services, and may aggregate anonymized information we receive through your use of the Life Sync Services with the anonymized information of other users of the Life Sync Services in order to improve the quality and value thereof.

Go Right will take commercially reasonable efforts to maintain physical, electronic, and procedural safeguards to protect information.

## **XI. Modification**

Go Right reserves the right to modify, discontinue, or terminate availability of the Life Sync Services, or modify the Terms, at any time and without prior notice. You will be notified each time Go Right modifies the Terms, and will be required to review and agree to the modified Terms in order to continue using the Life Sync Services.

## **XII. Ownership and License**

The Life Sync Application and Life Sync Skill, along with any other content provided by Go Right through the same, including trademarks, trade dress and copyrightable text (collectively, “Go Right Content”), are protected by copyright, trademark, and other laws of the United States and foreign countries and are the proprietary designations of Go Right. Any other trademarks, service marks, logos, trade names and any other proprietary designations are the trademarks or registered trademarks of their respective parties. You acknowledge and agree that the Life Sync Application, Life Sync Skill, and Go Right Content, including all associated intellectual property rights, are the exclusive property of Go Right. You will not remove, alter or obscure any copyright, trademark, service mark or other proprietary rights notices incorporated in or accompanying the Life Sync Application, Life Sync Skill, or Go Right Content.

Subject to your compliances with these Terms, Go Right grants you a limited, non-exclusive, non-transferable license to use the Life Sync Skill, and to view, download, and print any Go Right Content solely for your personal and non-commercial purposes. You may not use, copy, adapt, modify, prepare derivative worked based upon, distribute, download, license, sell, transfer, publicly display, publicly perform, transmit, stream, broadcast or otherwise exploit the Life Sync Services or Go Right Content, except as expressly permitted by these Terms. No licenses or rights are granted to you by implication or otherwise under any intellectual property

rights owned or controlled by Go Right or its licensors, except for the licenses and rights expressly granted in these Terms. Any misuse of the Life Sync Services or Go Right Content available via the same may be prosecuted by Go Right to the fullest extent permitted by law.

### **XIII. Feedback**

You may submit feedback regarding the Life Sync Services by emailing Go Right at [LifeSync@statefarm.com](mailto:LifeSync@statefarm.com). You acknowledge and agree that any feedback you submit may be used by Go Right for any purpose related to provision of the Life Sync Services.

### **XIV. General Prohibitions**

You agree not to do any of the following:

- Impersonate or misrepresent your affiliation with any person or entity;
- Violate any applicable law or regulation;
- Collect or store any information from users of Life Sync Services without their express permission;
- Post, upload, publish, submit, share, or transmit any information that: (i) infringes, misappropriates, or violates a third party's privacy or any rights of publicity, or any patent, copyright, trademark, trade secret, moral rights, or other intellectual property rights; (ii) violates, or encourages any conduct that would violate, any applicable law or regulation or would give rise to civil liability; (iii) is fraudulent, false, misleading, or deceptive; (iv) is defamatory, obscene, pornographic, vulgar, or offensive; (v) promotes discrimination, bigotry, racism, hatred, harassment, or harm against any individual or group; (vi) is violent or threatening or promotes violence or actions that are threatening to any person or entity; or (vii) promotes illegal or harmful activities or substances;
- Attempt to probe, scan, or test the vulnerability of any Go Right system or network or compromise any security or authentication measures;
- Avoid, bypass, remove, deactivate, impair, descramble, or otherwise circumvent any technological measure implemented by Go Right or any of Go Right's providers or any other third party (including another user) to protect the Services, Go Right Content, personal information of you or any other user of the Life Sync Services, or Account Content;
- Use the Life Sync Services to send any unsolicited or unauthorized advertising, promotional materials, or other form of solicitation;
- Use any meta tags or other hidden text or metadata utilizing a Go Right trademark, logo URL, or product name without Go Right's express written consent;
- Use the Life Sync Services, Go right Content, information of any user of the Life Sync Services for any commercial purpose or the benefit of any third party or in any manner not permitted by these Terms;
- Attempt to decipher, decompile, disassemble or reverse engineer any of the software used to provide the Life Sync Services;

- Interfere with, or attempt to interfere with, the access of any user, host or network, including, without limitation, sending a virus, overloading, flooding, spamming, or mail-bombing the Life Sync Services; or
- Encourage or enable any other individual to do any of the foregoing.

Go Right will have the right to investigate and prosecute violations of any of the above to the fullest extent of the law. Go Right may involve and cooperate with law enforcement authorities in prosecuting users who violate these Terms.

You acknowledge that Go Right has no obligation to monitor your access to or use of the Life Sync Services or to review or edit any of your information, but has the right to do so for the purpose of operating and providing the Life Sync Services, to ensure your compliance with these Terms, and to comply with applicable law or the order or requirement of a court, administrative agency or other governmental body.

Go Right reserves the right, at any time and without prior notice, to remove or disable access to any Account Content that Go Right, at its sole discretion, considers to be in violation of these Terms or otherwise harmful to the Life Sync Services.

#### **XV. Termination**

If you violate these Terms, Go Right has the right to suspend or disable your access to the Life Sync Services, at its sole discretion and without prior notice to you. Go Right reserves the right to revoke your access to and use of the Life Sync Services at any time, with or without cause. You may discontinue use of the Life Sync Services at any time.

#### **XVI. Disclaimers**

THE LIFE SYNC APPLICATION AND ANY CONTENT WITHIN THE LIFE SYNC SERVICES ARE PROVIDED “AS IS”, WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED. WITHOUT LIMITING THE FOREGOING, GO RIGHT EXPLICITLY DISCLAIMS ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, QUIET ENJOYMENT OR NON-INFRINGEMENT, AND ANY WARRANTIES ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE. GO RIGHT MAKES NO WARRANTY THAT THE LIFE SYNC SERVICES OR GO RIGHT CONTENT WILL MEET YOUR REQUIREMENTS OR BE AVAILABLE ON AN UNINTERRUPTED, SECURE, OR ERROR-FREE BASIS. GO RIGHT MAKES NO WARRANTY REGARDING THE QUALITY OF ANY SERVICES OR GO RIGHT CONTENT AVAILABLE FROM OR OBTAINED THROUGH THE LIFE SYNC SERVICES OR THE ACCURACY, TIMELINESS, TRUTHFULNESS, COMPLETENESS, OR RELIABILITY OF ANY GO RIGHT CONTENT OR OTHER INFORMATION OBTAINED OR SHARED THROUGH THE LIFE SYNC SERVICES. GO RIGHT HAS NO RESPONSIBILITY OR LIABILITY FOR THE TRUTHFULNESS OR ACCURACY OF ANY INFORMATION YOU OR YOUR CARE CIRCLE PROVIDES OR SHARES USING THE LIFE SYNC SERVICES.

NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM GO RIGHT OR THROUGH THE LIFE SYNC SERVICES, WILL CREATE ANY WARRANTY NOT EXPRESSLY MADE HEREIN.

**XVII. Indemnity**

YOU AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS GO RIGHT, ITS OFFICERS, DIRECTORS, EMPLOYEES AND AGENTS, FROM AND AGAINST ANY CLAIMS, LIABILITIES, DAMAGES, LOSSES, AND EXPENSES, INCLUDING, WITHOUT LIMITATION, REASONABLE LEGAL AND ACCOUNTING FEES, ARISING OUT OF OR IN ANY WAY CONNECTED WITH (I) YOUR ACCESS TO OR USE OF THE LIFE SYNC SERVICES, ANY GO RIGHT CONTENT OR ANY OTHER INFORMATION SHARED OR OBTAINED THROUGH THE LIFE SYNC SERVICES, (II) ANY USE OF THE LIFE SYNC SERVICES FOR ANY UNLAWFUL OR INAPPROPRIATE CONDUCT, OR (III) ANY ACT OR OMISSION BY YOU THAT CONSTITUTES AN ACTUAL OR ALLEGED VIOLATION OF THESE TERMS.

**XVIII. Limitation of Liability**

YOU ACKNOWLEDGE AND AGREE THAT, TO THE MAXIMUM EXTENT PERMITTED BY LAW, THE ENTIRE RISK ARISING OUT OF YOUR ACCESS TO AND USE OF THE LIFE SYNC SERVICES REMAINS WITH YOU. NEITHER GO RIGHT NOR ANY OTHER PERSON OR ENTITY INVOLVED IN CREATING, PRODUCING, OR DELIVERING THE APPLICATION WILL BE LIABLE FOR ANY INCIDENTAL, SPECIAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES, INCLUDING LOST PROFITS, LOSS OF DATA OR LOSS OF GOODWILL, SERVICE INTERRUPTION, COMPUTER DAMAGE OR SYSTEM FAILURE OR THE COST OF SUBSTITUTE PRODUCTS OR SERVICES, OR FOR ANY DAMAGES FOR PERSONAL OR BODILY INJURY OR EMOTIONAL DISTRESS ARISING OUT OF OR IN CONNECTION WITH THESE TERMS OR FROM THE USE OF OR INABILITY TO USE THE LIFE SYNC SERVICES OR THE INABILITY TO USE OR ACCESS ANY SPECIFIC INFORMATION USING THE LIFE SYNC SERVICES, WHETHER BASED ON WARRANTY, CONTRACT, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR ANY OTHER LEGAL THEORY, AND WHETHER OR NOT GO RIGHT HAS BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGE, EVEN IF A LIMITED REMEDY SET FORTH HEREIN IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

IN NO EVENT WILL GO RIGHT'S AGGREGATE LIABILITY ARISING OUT OF OR IN CONNECTION WITH THESE TERMS OR FROM THE USE OF OR INABILITY TO USE THE LIFE SYNC SERVICES EXCEED THE AMOUNT OF ONE HUNDRED DOLLARS (\$100).

**XIX. Controlling Law and Jurisdiction**

These Terms and any action related thereto will be governed by the laws of the State of Illinois without regard to its conflict of laws provisions. The exclusive jurisdiction and venue of any action to prevent the actual or threatened infringement, misappropriation or violation of a party's copyrights, trademarks, trade secrets, patents or other intellectual property rights, will be the state and federal courts located in the Central District of Illinois and each of the parties hereto waives any objection to jurisdiction and venue in such courts.

## **XX. Entire Agreement**

These Terms constitute the entire and exclusive understanding and agreement between Go Right and you regarding the Life Sync Services, and these Terms supersede and replace any and all prior oral or written understandings or agreements between Go Right and you regarding the Life Sync Services.

## **XXI. Assignment**

You may not assign or transfer these Terms, by operation of law or otherwise, without Go Right's prior written consent. Any attempt by you to assign or transfer these Terms, without such consent, will be null and of no effect. Go Right may assign or transfer these Terms, at its sole discretion, without restriction. Subject to the foregoing, these Terms will bind and inure to the benefit of the parties, their successors, and permitted assigns.

## **XXII. Notices**

Any notices or other communications permitted or required hereunder, including those regarding modifications to these Terms, will be in writing and given by Go Right: (i) via email (in each case to the address that you provide); or (ii) by posting in the Life Sync Application or sending you notification via the Life Sync Skill. For notices made by e-mail, the date of receipt will be deemed the date on which such notice is transmitted.

## **XXIII. Miscellaneous**

The failure of Go Right to enforce any right or provision of these Terms will not constitute a waiver of future enforcement of that right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Go Right.
